- 2. The Committee will consider the complaints from women employees/trainees of the NSTI Ludhiana/RDSDE Punjab only relating to sexual harassment. The word "Sexual Harassment" will include such unwelcome sexually determined behavior, whether directly or otherwise such as;
 - I. Physical contact and advance;
 - II. Demand or request for sexual favours;
 - III. Sexually coloured remarks;
 - IV. Showing any pornography; or

- V. Any other unwelcome physical, verbal or non-verbal conduct of sexual nature.
- 3. The committee will provide, where necessary, a special counselor or other support service including maintenance of confidentiality of the complaints and ensure time bound treatment and Redressal of complaints made by women employees.
- 4. The guidelines of Supreme Court in this regard as issued vide DoPT's O.M. dated13.02.1998 are enclosed for the use of Members of the Committee.
- 5. As per the guidelines, the Committee shall meet at least once in every quarter even if no live case is available, to review the preparedness and fulfill the requirements of the apex Court's judgment in Vishaka case. The committee shall be responsible for appropriate action in this regard.
