

3. Validity of offer should be minimum 30 days from date of opening the tender.

5. The tender submitted in prescribed Time Limit shall be opened at **15:30 hrs on 14.01.2021**. The firm willing to attend Bid Opening can depute their representative with authorization letter signed by the competent authority in original alongwith ID proof.
6. Tenders should be quoted as "F.O.R. NSTI, LUDHIANA".
7. Detail of Taxes/ GST etc. should be indicated in offer (if applicable.)
8. Payment may be made within 30 days after completion of work at NSTI, Ludhiana.
9. The supplier/contractor is advised to submit its **Bank Details/Mandate Form for e-payment**.
10. **PERFORMANCE SECURITY: 10% of the Total value of item in the favour of the DDO, NSTI, Ludhiana may be submitted along with the tender which will be returned after completion of purchase process.**
11. Any dispute will be taken up in the jurisdiction of Ludhiana.
12. Clarifications, if any can be sought from the Purchase section of Institute from 14.30 to 16.30 Hrs. on any working day.
13. Tenders should be submitted in English or Hindi language only. The bid should also contain self signed copy of firm's GST registration certificate. The original proposal shall be ink signed. It shall contain no overwriting, except as necessary to correct errors made by the bidder itself. Any such corrections must be initialed by the person who signs the proposals. All papers of proposal must be signed by the same person who signs the proposals.
14. If the Contractor fails to complete the works within stipulated period, action as deemed fit will be taken.
